For UNITE HERE HEALTH

This is a summary of the annual report of UNITE HERE HEALTH, EIN 23-7385560, Plan No. 501, for the period of April 1, 2020 through March 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The trustees of UNITE HERE HEALTH have committed to pay from the Trust Fund certain medical, dental, prescription drug, vision, death and disability benefit claims incurred under the terms of the plan.

Insurance Information

The plan had contracts with Dearborn National Life Insurance Company, Nevada Dental Benefits, Ltd., Alpha Dental Programs, Inc., UnitedHealthcare Insurance Company, Kaiser Foundation Health Plan Inc., Cigna Health and Life Insurance Company, Kaiser Foundation Health Plan of Colorado, Kaiser Foundation Health Plan of Georgia, Kaiser Foundation Health Plan of the Mid-Atlantic, Davis Vision, Liberty Dental Plan of California and Vision Service Plan to pay certain health, dental, vision and life insurance claims incurred under the terms of the plan. The total premiums paid for the plan year ending March 31, 2021 were \$164,795,388.

Because the plan contract with Atlantic Southern Dental Foundation is an “experience-rated” contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premium paid for the plan year ending March 31, 2021, the premium paid under such “experience-rated” contracts were \$3,148,569 and the total of all benefit claims paid under these experience-rated contracts during the year was \$2,879,553.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$552,310,898 as of March 31, 2021, compared to \$925,098,544 as of April 1, 2020. During the plan year, the plan experienced a decrease in its net assets of \$372,787,646. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan’s assets at the end of the year and

the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$734,356,641 including employer contributions of \$593,122,037, employee contributions of \$24,489,585, realized gain of \$14,228,771 from the sale of assets, earnings from investments of \$89,525,967, and other income of \$12,990,281.

Plan expenses were \$1,107,144,287. These expenses included \$93,556,104 in administrative expenses, and \$1,013,588,183 in benefits paid to participants and beneficiaries.
