Nevada Health Solutions

Nevada Health Solutions (NHS) continues to enhance the process for submitting Prior Authorization (PA) requests for our community partners.

Did you know you could also submit PA requests online using Connect, our Web-based tool that accepts prior authorization requests 24 hours a day, seven days a week? In addition, you can check the status of a prior authorization.

Using online options for PA requests replaces the need to call or fax paper forms to NHS. It provides immediate confirmation upon receipt without the need to resubmit requests or call to check status.

Pharmacy News

Prescription drug abuse has become a national epidemic in recent years. The Culinary Health fund has brought together resources to identify ways we can help our participants who have no alternative for pain treatment other than to use pain medication and for those who are seeking an alternative to pain medication.

In an effort to ensure our participants have access to safer, more effective chronic pain treatment while reducing misuse, abuse or overdose from these drugs, the Culinary Health Fund is announcing the following policy change for opioid prescriptions:

Starting January 1st, we will limit opioid prescriptions written by out-of-network providers to 7 days. Participants who receive treatment from out-of-network providers will not be able to refill these prescriptions after the initial 7 days. Any opioid prescription written by an out of network provider will not be covered by your insurance after day 7.

For our existing participants who receive treatment from an out of network provider, we will assist them with locating an innetwork provider so they may receive an evaluation for pain medication.

We thank you for utilizing the CDC Guideline for Prescribing Opioids for Chronic Pain when prescribing opioids for acute and chronic pain. Besides encouraging safe pain medication prescribing practices, we encourage providers to assist their patients with transitioning away from high dose opioids and move toward a comprehensive treatment plan for pain management.
