Pharmacy Updates

Prescribing VASCEPA:

The recent REDUCE-IT trial showed that patients with elevated triglyceride levels despite the use of statins, the risk of ischemic events, including cardiovascular death, was significantly lower among those who received 2 g of icosapent ethyl twice daily than among those who received placebo. (Cardiovascular Risk Reduction with Icosapent Ethyl for Hypertriglyceridemia, Bhatt DL, Steg PG, Miller M et al N Engl J Med. 2019;380(1):11. Epub 2018 Nov 10).

Based on the REDUCE-IT study results, there have been no related Society Guideline changes. On the contrary, Uptodate has the following disclaimer: "The role of highly purified fish oil in patients with increased cardiovascular risk has been uncertain". Because of limitations in this trial (eg, mineral oil may not be a true placebo), confirmation of these findings from ongoing trials is needed before a firm recommendation can be made about the role of fish oil supplementation in this patient population."

This has led us to review our formulary and prescribing patterns as there are clear indications for this medication and we want to ensure the right patients are prescribed this medication. We have instituted an evidence based prior authorization for all existing and new to start prescriptions.

Please be advised that prior authorization must in place prior to 4/1/19 for your patients to receive their refills and prior authorization will be required thereafter for new starts as well.
