RE: IMPORTANT HEALTH SERVICES COALITION (HSC) HOSPITAL NETWORK CHANGE

To whom it may concern:

The Health Services Coalition (HSC) represents 26 employer and union sponsored Health Plans in Southern Nevada with more than 280,000 covered lives collectively. Over the last year the HSC has been engaged in contract negotiations with Dignity Health System. To date the two groups have not reached an agreement. We recognize the significant amount of planning and effort it will take to move care for this many patients, so in an effort to minimize patient and provider disruption please note the risk this contract may terminate December 31, 2023.

What this means to you and to your practice is that the Dignity Health System may no longer be contracted with the Health Services Coalition (HSC) effective January 1, 2024. Therefore, should an agreement not be reached, effective January 1, 2024, patients who are members of all the organizations listed on this letterhead below, SHOULD NOT have ANY SERVICES scheduled or rendered at any of the following facilities:

If the Dignity contract expires, Coalition patients treated in the Dignity system will be reimbursed under the federal Surprise Medical Billing requirements. Please take special consideration of this information as you work with your patients in the scheduling of medical services and ensure such services are scheduled at any of the other acute care hospitals, including the following HSC partners, Valley Health System Facilities, HCA facilities, UMC and North Vista Hospital, who will remain contracted with the Health Services Coalition after January 1, 2024.
