Tamiflu Prescriptions

If you write a prescription for Tamiflu, please send it to a retail pharmacy, as the Culinary onsite pharmacies do not carry Tamiflu and it may cause a delay for your patient.

Telehealth Updates

The Culinary Health Fund previously notified our network to use CPT codes 99441-99443 with Place of Service Code 02 for telehealth services.

We are expanding the billable CPT codes to include 99421-99423.

COVID-19 Testing

CPL is our capitated laboratory provider and COVID test samples need to be sent there for processing. CPL is the only contracted lab for these tests.

We are not covering COVID test processing done in the provider's office at this time. Specimens need to be sent to CPL for processing.

Prior Authorization Requests



Save yourself time – Did you know you can submit PA requests and supporting documentation as attachments online using our Web-Based Authorization Portal? In addition, you can check the status of a prior authorization, or if one has already been started.

It is available for you 24/7 and is in real time.

Using online options for PA requests replaces the need to call or fax paper forms to NHS and increases the efficiency of your staff. The Portal provides immediate confirmation upon submission with a reference number. Keeping with the paperless trend you can also download a pdf with the PA information for your records.
