IMPORTANT

We notified the network in December of the Culinary Health Fund's new EDI Payer ID.

We are still having many providers submit under the old Payer ID. Effective February 28, 2021 providers will no longer be able to see eligibility and claim inquiry transactions. Please make sure you are using the following information:

Note: Your clearinghouse vendor may need to update the payer ID in their system as well.

If you previously submitted claims to the old EDI Payer ID <u>please</u> <u>do not resubmit your claims</u>. They will be forwarded for processing as normal.
