### **Electronic Billing Updates**

#### **IMPORTANT**

We notified the network in December of the Culinary Health Fund's new EDI Payer ID. We are still having many providers submit under the old Payer ID. As of February 28, 2021, providers can no longer see eligibility and claim inquiry transactions if they are submitted under the old EDI payer ID.

## **Eligibility Delay Reminder**

Due to the high volume of participants taking advantage of the benefits extension plan known as Super Saver, offered to CHF members and allowing them to self-pay in order to keep their benefits, there has been a resultant delay in the system updating their eligibility.

We ask that you allow your Culinary patients to present their selfpay receipt or confirmation number as proof of eligibility if the system has not been updated. Currently, there is a 1-3-day delay.
