## **New Provider Directory Requirements**

As part of the Consolidated Appropriations Act (CAA), you will be asked to verify your online provider directory information **every 90 days**. Culinary Health Fund staff will be reaching out to the network via fax/email and/or phone to try to verify your information. If you do not verify and/or report any changes or inaccuracies, we are required to remove your information from our online provider directory.

Here is what you can do now:

- Review your online provider directory information on a regular basis to ensure it is correct.
- ➤ Update your information when it changes, including any providers that leave or join your practice.

Any provider who needs to update demographic information should submit an **Address Information** Form. If a new provider will be joining your practice, please complete a **Group Add Request** form. These forms can be found on our website at www.culinaryhealthfund.org.
