## **Pharmacy Corner**

# Adult 60+ RSV vaccine coverage added to Rx benefit, effective 1/1/2024.

Culinary Health Fund covers new Respiratory Syncytial Virus (RSV) vaccines Abrysvo and Arexvy with \$0 costshare for eligible participants (ages 60 and older) at participating retail pharmacies (i.e., Walgreens and CVS). **For Abrysvo only**, coverage is also available for pregnant individuals at 32-36 weeks gestational age following CDC recommendations.

Participants outside of ages 60 and older or who are not 32-36 weeks gestational age are not eligible for RSV vaccination under the Rx benefit.

If RSV vaccination is right for your patient, then please have them schedule an appointment with their participating pharmacy.

## **Dignity Health Update**

The Health Services Coalition and the St. Rose Las Vegas valley hospitals signed a one-year extension on their contract. This will allow you and/or your patients to continue utilizing their facilities for services for the time being.

We will keep you up to date throughout the year with any updates on their continuing contract negotiations.
