Provider Portal – Two-Factor Authentication

Zenith American recently implemented two-factor authentication on the Provider Portal used to check claims and eligibility for your patients.

Two-factor authentication adds extra security to your account by requiring a second factor, such as a code sent to a mobile device or email. This helps prevent unauthorized access and protects against security breaches.

What does this mean for you? This means that a unique code will be required to log in from now on. You can choose to receive this code via email or cell phone.
