### **Pharmacy Updates**

#### Discontinuation of Bydureon BCise and Byetta

Drug manufacturer AstraZeneca (AZ) recently notified the U.S. Food and Drug Administration (FDA) that it discontinued Bydureon BCise and Byetta. Bydureon BCise was discontinued on Oct. 28, 2024, and Byetta was discontinued on Oct. 25, 2024.

#### What this means for you:

We've identified preferred covered alternatives to help ensure your patients with Culinary Health Fund benefits continue to have access to a covered glucagon-like peptide (GLP-1) receptor agonist product to treat diabetes. The following are preferred covered alternatives: Mounjaro, Ozempic, Rybelsus, Trulicity and liraglutide (Victoza authorized generic).

#### HIV PrEP coverage - Updated January 1, 2025

The Departments of Health and Human Services, Labor and the Treasury (the Departments) issued a new FAQ about the Affordable Care Act (ACA), Part 68 (FAQ 68) on Oct. 21, 2024. This FAQ clarifies the Departments' expectations regarding coverage of HIV Pre-exposure Prophylaxis (PrEP) without cost-sharing, in connection with the latest United States Preventive Services Task Force (USPSTF) PrEP recommendation issued on Aug. 22, 2023.

The new guidance clarifies the requirement of covering specific HIV PrEP treatments, listing the two oral medications (generic Truvada and Descovy) and one injectable (Apretude), as well as prohibiting the use of medical management strategies.

In response to the Departments' FAQs, Apretude and Descovy were added to the Optum Rx Premium Formulary for Culinary Health Fund participants, effective January 1, 2025.

Additionally, the Health Care Reform (HCR) Preventive Medication List was updated to allow these medications to pay at \$0 cost-share for PrEP. The coverage list removed the step therapy requirement through generic Truvada for Descovy and Apretude, allowing these PrEP medications to pay at \$0 cost-share without a copay waiver requirement.

#### **Biosimilar Formulary Updates**

Beginning July 1, 2025, Optum Rx will prefer **Wezlana**, the FDA-approved biosimilar to Stelara, on the Premium Formulary. Wezlana has no clinical differences compared to Stelara, but offers several positive attributes:

- First interchangeable Stelara (ustekinumab) biosimilar to market.
- Available in all the same drug formulations and strengths as Stelara.
- Latex-free.
- FDA-approved for all of the same indications as Stelara.

Reminder: As of January 1, 2025, Optum Rx preferred the FDA-approved adalimumab biosimilar **Amjevita by Nuvaila** on the Premium Formulary. Participants currently utilizing Humira will need to transition to the preferred biosimilar or their next refill may be delayed. A new script for Amjevita by Nuvaila will need to be submitted to their specialty pharmacy.
