# Introducing Cologuard® for Colorectal cancer (CRC) screening.

CRC is the second leading cause of cancer deaths in the United States, taking the lives of about 50,000 Americans per year—more than either breast cancer (41,000/year) or prostate cancer (29,000/year).<sup>1</sup>

By making a variety of CRC screening options available to our members at no cost through their preventive health benefits, Culinary Health Fund is committed to promoting shared decision-making in helping all of our eligible members are screened for CRC. This includes noninvasive screening options, such as Cologuard®.

Cologuard® is a noninvasive stool-based test that detects blood and abnormal DNA that are associated with CRC and pre-cancer. The collection kit is shipped to and from the patient's home via UPS, and Exact Sciences Laboratories (ESL) provides results to your practice within a few weeks. Cologuard® also includes an embedded patient navigation program administered by ESL that provides follow-up calls and outreach to support patient compliance. Cologuard® is covered for use every 3 years with no patient copay or prior authorization required.

# **Pain Management Alternatives**

As you are aware, prescription drug abuse has become a national epidemic in recent years. In an on-going effort, the Culinary Health Fund has been campaigning to provide options and alternatives for pain management. The following are a list of services available to eligible Culinary members:

#### **Acupuncture Services:**

As of February 2019, Culinary Health Fund added acupuncture as a new benefit for its members struggling with pain and nausea related symptoms. To date, we have 10 contracted acupuncture providers throughout the valley to service our members.

### **Chiropractic Services:**

In expanding options to effectively manage chronic pain, studies have shown chiropractic manipulation to be an effective alternative to pain medication. So much so that beginning this past March, the Missouri Department of Social Services began reimbursement for chiropractic services in the treatment of chronic pain.

The American College of Physicians now recommends spinal manipulation along with heat, massage and acupuncture as alternatives to pain relieving drugs as part of their updated low back guidelines.

Additional studies show chiropractic care, including manipulation and associated modalities, as an effective treatment of migraines, both with and without aura, with the follow-up studies participants exhibiting symptom free for months post treatment.

#### **Physical Therapy Services:**

The Culinary Health Fund has multiple providers specializing in physical therapy. You may find patients benefit from such therapy to help with the following:

Reduce or eliminate pain

Avoid surgery

Improve mobility

Recover from a stroke

Recover from or prevent a sports injury

Improve your balance and prevent falls

Manage diabetes and vascular conditions

### **Claims Corner**

#### Drug Administration Codes and J-codes - Make Sure They Match

If you bill the Culinary Health Fund for the administration of drugs, the drug codes (HCPCS "J" codes) need to match the number of administrations.

**Example**: A patient receives an injection of a steroid as well as an antihistamine. There should be two injection administration codes on the bill submitted to Culinary along with the two J-codes for the drugs. Because there were two drugs administered there should be two administration codes.

Make sure the number of your drug admin units is equal to the total number of drugs injected.
