New Controlled Substance e-Prescribing Requirements

Starting January 1, 2020, OptumRx will only accept e-prescriptions for controlled substances at our home delivery pharmacy.

Why the change?

- Thirty-six percent of all opioid-related deaths in the United States involve a prescription.¹
- E-prescribing helps improve prescribing accuracy, reduce dispensing errors and improve administrative and cost efficiency.²
- More states are mandating e-prescriptions for controlled substances.³
- Federal law will require e-prescriptions for controlled substances under Medicare Part D by January 1, 2021.⁴

What does this mean for you and your patients? As of January 1, 2020, you will need to e-prescribe all controlled substances for patients who get their medication by home delivery through OptumRx. Non-electronic prescriptions will not be filled.

How can you make sure your practice is ready? E-prescribing controlled substances requires two-

step authentication and other extra security, so make sure you and your electronic medical record (EMR) system are equipped.

Zelis Payments - EFT

Zelis Payments is going live in November! If you are currently set up with Zelis Payments or ePayment Center you will start receiving your claim payments via ACH very soon.

If you are with Payspan and are not registered with Zelis Payments or ePayment Center, you will revert to checks. To avoid reverting to checks, please call 855-774-4392 to get set up to continue receiving payments direct to your bank account.

NHS – Prior Authorization

Nevada Health Solutions (NHS) continues to enhance the process for submitting Prior Authorization (PA) requests for our community partners.

Did you know you could also submit PA requests online using Connect, our Web-based tool that accepts prior authorization requests 24 hours a day, seven days a week? In addition, you can check the status of a prior authorization. Using online options for PA requests replaces the need to call or fax paper forms to NHS. It provides immediate confirmation upon receipt without the need to resubmit requests or call to check status.
