


# A New Benefit for Families

**For the first time, children of eligible Culinary participants  
can receive Applied Behavior Analysis Therapy.**



Beginning January 1, 2017, the Culinary Health Fund implemented a new limited benefit for Applied Behavior Analysis (ABA) Therapy for eligible children of Culinary Participants that have a diagnosis of Autism Spectrum Disorder.



**Culinary Participants must meet the coverage requirements to qualify for ABA Therapy. The Culinary Health Fund’s coverage guidelines are:**

- ❖ The child must be at least 2 years old and younger than 6 years old, have a valid diagnosis of Autism Spectrum Disorder (ASD), and have a prorated mental age (PMA) of at least 11 months.
- ❖ The therapy must be ordered by a pediatrician, a child psychiatrist or child psychologist. The therapy may also be ordered by another type of provider operating within the scope of his or her state license.
- ❖ The supervising provider must be certified and licensed by the Behavioral Analyst Certification Board (BACB) as a Board Certified Behavior Analyst (BCBA) or Board Certified Behavior Analyst Doctorate (BCBA-D). The supervising provider may also be another type of provider operating within the scope of his or her state license.
- ❖ The individual providing the ABA Therapy under the supervising provider must be trained and certified by the BACB, including but not limited to a Board Certified Assistant Behavioral Analyst (BCaBA) or Registered Behavioral Technician (RBT). The individual providing the ABA Therapy may also be another type of provider operating within the scope of his or her state license.
- ❖ The ABA Therapy and treatment plan must be pre-certified, and the treatment notes and treatment plan must be reviewed semi-annually. Future therapies may not be considered a covered expense if the patient is not demonstrating - to the Culinary Health Fund’s satisfaction - any improvement, or if the child or his or her parents are not adhering to the treatment program.
- ❖ Parent/caregiver training and support must be incorporated as part of the treatment plan.
- ❖ Benefits will be paid up to the maximum number of hours determined necessary under the applicable treatment plan, not to exceed 30 hours of ABA Therapy per week.
- ❖ Coverage for ABA Therapy will cease on the first to occur of the following dates: (a) the date the child reaches 6 years of age when the child will become eligible for ABA therapy and other related services through the school system; or (b) the date any of the previous criteria cease to be met.
- ❖ \$10 copay per day of treatment, regardless of the number of hours of treatment or the number of ABA Therapy providers that treat the eligible dependent during the day, customized to the child’s needs and abilities.

The Culinary Pharmacy, a pharmacy exclusively for Culinary participants, is in a convenient location on the Las Vegas strip, across from the Stratosphere. It is one of the busiest pharmacies in Nevada.

It recently incorporated new technology to save participants time and made it easier to get refills. Now, participants can refill their prescriptions online and receive updates about their medication through email and text messages. Culinary Participants must enroll to use these new features.

The sign up process for refills can be done online at: <https://culinary.webportalrx.com> or by visiting the pharmacy or calling (702) 650-4417.


Participants can stay informed about their medications by enrolling in the Culinary Pharmacy's text message and email program. Participants can sign up for the program at the Pharmacy and they will receive four message types:

- **Pick-Up Messages:** This will notify them when medicine is ready to be picked up.
- **Pick-Up Reminders:** This notification will message the patient every three days, as a reminder to pick up ready medications.
- **Refill Reminders:** This alert will remind the patient when eligible prescriptions can be filled.
- **STAT messages:** These alerts are sent directly from the pharmacy staff to notify the patient about any issues with filling their prescription.

### Your Role as a Provider

Please mention these great new features to your Culinary patients when you prescribe generic medications. All generic medication at the Culinary Pharmacy is free for Culinary participants.

You may see participants come to your office with a Culinary Pharmacy booklet that lists all the generic drugs available at the Pharmacy. Please prescribe generic medications when it is medically possible.

- Home assessment and planning for post-operative needs after surgery.




# CULINARY WELLNESS

Programs and classes to help Culinary participants live healthier lifestyles

The Culinary Health Fund offers several programs and classes to help your Culinary patients facilitate lifestyle changes to manage their health and wellness. The programs and classes are included in Culinary benefits and have no cost to participants. **Please refer your Culinary patients to the programs and classes that meet their health needs.**



**\*\*NEW\*\*  
Hypertension Program**

Beginning March 2017, the Culinary Health Fund partnered with Nevada Health Solutions’ Population Health Department to bring a class focused on managing and reducing high blood pressure to Culinary participants with uncontrolled or high-risk hypertension.

**Referrals from providers are required to attend this class. Referrals should be faxed to Nevada Health Solutions at (702) 691-5614.**

Class attendees receive blood pressure cuffs at no cost, important information about how to measure and check their blood pressure, and educational materials to help manage their hypertension.

**Healthier U Program**

Through the Culinary Health Fund’s “Healthier U” program, participants who are 18 years of age or older, partner with a certified Dietician/Nutritionist for up to 26 visits to learn how to eat healthier and make better food choices.

New program requirements: Referrals from doctors are no longer required. A Dietician/Nutritionist will determine if a participant qualifies for the program. Participants can find a Dietician/ Nutritionist online at [www.culinaryhealthfund.org](http://www.culinaryhealthfund.org).

Culinary Kids Healthier U is a 12-week program just for children. Children who are overweight (BMI ≥ 95th percentile for age) or at risk for chronic disease are eligible for the program. Pediatricians should refer children 7 -17 years old who meet the eligibility requirements to the Children’s Heart Center to join the program. Children under 7 years old are eligible to see a Dietician/Nutritionist. 


## Healthy Pregnancy Plus

The Healthy Pregnancy Plus program encourages female participants to visit their Obstetrician within the first trimester and attend their scheduled appointments throughout their pregnancy. Obstetricians who complete and submit the Healthy Pregnancy Notification and Risk Factor forms within the first 12 weeks of pregnancy receive \$100. The following forms should be submitted:

- Pregnancy Notification
- Low Dose Aspirin
- 17- Hydroxyprogesterone

Through the program, participants are encouraged to breastfeed. We offer a breastfeeding class for expectant mothers. The class teaches participants the importance of breastfeeding for a healthy baby and lifestyle. Participants also receive a breast pump and \$100. Your Culinary patients can sign up by calling the Advocacy Line at (702) 691-5665.



## Diabetes Rewards Program

Participants who have diabetes or are pre-diabetic should join the Diabetes Rewards Program.

Through a series of classes; including: Diabetes, Diabetes Plus, and Kidney Smart, participants learn the signs and symptoms of diabetes, how to manage their health condition, check their blood glucose levels, and maintain a healthy diet. The program also encourages participants to visit a Podiatrist and Ophthalmologist.

Your Culinary patients who register and attend the classes receive a glucose monitor, incentives, and a passport book to show their progress in the program. Your Culinary patients can sign up by calling the Advocacy Line at (702) 691-5665.



### **Call It Quits** (Smoking Cessation Program)

The Smoking Cessation Program consists of a class taught in partnership with the American Lung Association, counseling, nicotine replacement therapy, and education that provides useful tools to help participants quit smoking. Your Culinary patients can sign up by calling the Advocacy Line at (702) 691-5665.


A prescription from a physician is needed for Culinary participants to receive nicotine replacement therapy.

### **Breast Care Program**

The Breast Care Program provides female Culinary participants with the support they need during the breast cancer screening process, diagnosis, and treatment.

Please refer female Culinary participants who are 35 and older and have not had a mammogram within the last 12 months to Desert Radiologists to get a mammogram. They will not have a copay for the exam. They can get a 3D mammogram for a \$75 fee. Call (702) 759-8700 to schedule an appointment.

After a mammogram, results are sent to the referring doctor. The Culinary Health Fund's Advocacy department follows up with the doctor's office to ensure the results have been received. Upon diagnosis, Nevada Health Solutions provides Culinary participants with support by helping to coordinate their care.
